DIRECTIONS: Coming from the South: Highway 71 North into downtown. Continue on 1-29/1-35 North and cross the river on the new Bond Bridge (used to be Paseo). Take the first exit off the bridge onto Bedford Street. Turn right on Bedford and continue 3 blocks to Saline Street. Turn right on Saline Street. We are in the middle of the block on the left – look for a yard and lots of trees. Address is 1331 Saline Street.

Coming from the North: 1-29/1-35 South. Just before crossing the river on the new Bond Bridge (used to be Paseo), take the Levee Road exit. Follow Levee Road for 3 blocks and turn left on Saline Street. We are in the middle of the block on the right – look for a yard and lots of trees. Address is 1331 Saline Street.

PURPOSE: The evaluation may only be performed for the purpose of evaluating teams for Pet Partners, and may not be performed in conjunction with evaluations for other therapy animal organizations, the AKC Canine Good Citizenship test, to certify an animal as a service animal, or for any other purpose (from Delta Society's *Policies and Procedures Manual*).

Appointments must be made. Appointments will be made in the order received.

Please include a copy of proof of current vaccinations, including rabies, with this form.

Please do **NOT** arrive more than 30 minutes before your scheduled time.

Mo-Kan Pet Partners Evaluation Information Sheet

MO-KAN's purpose is to provide safe animal-assisted activity and therapy services to health and educational facilities by volunteers and their companion animals, making sure the teams are evaluated using Delta Society methods and procedures and are registered with the Pet Partner's program.

The evaluation begins when the handler leaves their car and ends when entering the car after the evaluation.

Please note that you and your animal are being evaluated as a team. This is a simulated visit; please dress accordingly. Treat the evaluation as if it were a visit to an institution.

Be proactive with your pet, talk to your pet, and do what is necessary to make your pet and yourself comfortable.

- **Required** items to be provided by the Handler:

1. Completed Handler's Questionnaire
2. Towel or small blanket if the animal will be carried (cat or very small dog).
3. Acceptable collar or harness and leash.
4. The animal's brush or comb.
5. Treat for one of the exercises (Optional).

Evaluations are scheduled throughout the year. Dates and locations are posted on the MO-KAN website, www.mo-kanpetpartners.org.

Team ratings are reported to Delta after each evaluation. In the setting of a reevaluation, should a rating or equipment change occur, the most recent evaluation results prevail.

It is the responsibility of the handler to schedule their reevaluation before their badge expiration date. Members are not allowed to visit with an expired badge.

MO-KAN members are responsible for at least four volunteer hours each year, either at a facility or assisting at a MO-KAN event.
